<b>What is the overall deductible?</b>	Network: \$2,900 Individual / \$5,800 Family out-of-Network: \$5,000 Individual / \$10,000 Family Per calendar year.	Generally, you must pay all of the costs from providers up to the deductible amount before this plan begins to pay. If you have other family members on the plan, each family member must meet their own individual deductible until the total amount of deductible expenses paid by all family members meets the overall family deductible.
<b>Are there services covered before you meet your deductible?</b>	Yes. <u>Preventive care</u> is covered before you meet your deductible.	This plan covers some items and services even if you haven't yet met the deductible amount. But a <u>copayment</u> or <u>coinsurance</u> may apply. <b>What is not included in the out-of-pocket limit?</b>	Premiums, <u>balance-billing</u> charges (unless <u>balanced billing</u> is prohibited), health care this plan doesn't cover and penalties for failure to obtain <u>preauthorization</u> for services.
